1. Call to Order:

a. The January 2025 meeting of the TCLB board of directors was called to order at 8:30am by Suzanne Spellen (SS).

2. Roll Call:

- a. Suzanne Spellen called the roll. Present: Suzanne Spellen (SS), Brian Barker (BB), Andrew Cooper (AC), Monica Kurzejeski (MK), Tamara DeMartino (TD), Brian Sano (BS), Bob Connelly (BC) Bradley Lewis (BL, TCLB ED), and Paul Donnelly (PD, TCLB PM) Absent: Seamus Donnelly (SD), Jamie Magur (JM)
- b. Guests: Rev. Burkes, TCLB Realtor
- 3. Meeting Minutes: Motion made by MK to approve the December 18, 2024 board meeting minutes. Second by BS. Motion passed unanimously.
- 4. Financial Report: BL reviewed the P&L and end of year reports. MK noted that it would be helpful to find a way to track the neighborhood economic impact of the various TCLB initiatives. Resolution: The 2023 Paris Report has been drafted and a resolution to adopt PARIS Report and certify was out before the board for discussion. Motion to accept PARIS Report and to certify was made by MK. Seconded by SS. Motion passed unanimously. The 2024 PARIS reporting period begins this month.
- 5. Executive Director's Report: BL reviewed the ED report noting The Record and WTEN coverage of TCLB's target neighborhood progress removing red X's from previously condemned buildings, progress with the 791 River Street sale and the LBI Phase 2 of \$1.2M in funds available for TCLB neighborhood development initiatives. PD noted good progress with the various current contracts and their respective contractors.

 - **791 River Street:** Resolution to enter into Contract for Sale. Motion by MK, Second by BB. Motion passed unanimously.
